- 5) Request Direction on Assembly Bill 1407 (Friedman) Reckless Driving: Speed Contests: Vehicle Impoundment
 - The City Council Liaisons supported AB 1407.

- 6) Request Direction on Senate Bill 23 (Wiener) Unlawful Entry of a Vehicle
